
➤ The NOC will be valid for two academic years w.e.f August, 2010.

The approval is subject to the fulfillment of the following **general conditions**, failing which appropriate penal action including withdrawal of Approval/NOC may be initiated against the ITC and all liabilities arising out of such withdrawal would solely be that of the ITC:

1. A registered undertaking on Non-Judicial Stamp Paper of not less than Rs. 5/- stating that the ITC shall abide by all the Regulations, Guidelines, Norms and Standards of DGE&T/ Department, as applicable from time to time, must be submitted to the concerned principal of ITI declared as Controlling Officer.
2. Society/Trust/ Training Centre shall not use the nomenclature of 'Industrial Training Institute' which is reserved for Govt. institutions as per DGE&T norms and reference shall be made only by the name of '**Industrial Training Centre**' for all purposes and intents such as correspondence, advertisements, promotion literature etc.

3. The curriculum of the trade shall be as prescribed by DGE&T/NCVT.
4. No sharing of resources/premises for any other purpose shall be permissible.
5. The Society / Trust shall not allow closure of the ITC or discontinuation of the trade(s) or start of any new trade(s) without the prior approval of the Department/ Govt.
6. The ITC shall operate only from the approved / inspected location and shall not open any off-Campus study Centres.
7. The Accounts of the ITC shall be maintained separately and audited annually by a certified Chartered Accountant which shall be open to inspection by the Department/ DGE&T.
8. The Principal, Instructors and other staff be selected according to qualification and experience prescribed by DGE&T from time to time.
9. Society will make all the payment of its employees through Bank and the statement of payment shall be shown by the Society at the time of inspection.
10. All the laboratories, workshops etc. equipped as per DGE&T norms must be in operational condition before making admissions.
11. The Department may also conduct inspections with or without notifying the dates to verify any mis-representation, malpractices, violation of norms and standards of DGE&T/ Departmental Policy, etc
